PART II: ELIGIBILITY REQUIREMENTS AND RELEASES

- 1) You must be a U.S. citizen or legal permanent resident of the United States.
- 2) You must be at least 21 years of age.
- 3) You must not be a candidate for public office and must agree not to become one until at least one (1) year after the initial broadcast of the Program or any programs in which you appear, if selected as a participant and if such Program or programs are broadcast.
- 4) Neither you nor any member of your immediate family or anyone living in your household may be or may have been within the past two (2) years an employee, officer, director or agent of any of the following:
 - (a) Producers;
 - (b) Any television network, station or channel, cable network or satellite network that airs or that may air the Program;
 - (c) Any person or entity involved in the development, production or distribution or other exploitation of the Program or any variation thereof; including, without limitation, Flashlight 21, Inc.
 - (d) Any sponsor of the Program or its advertising agency; or
 - (f) Any person or entity supplying services or prizes to the Program.

In addition, Producers reserve the right to render ineligible any person whom any of them determine, in their sole discretion, is sufficiently connected with the production, administration, judging, or distribution of this Program such that his or her participation in the Program could create or contribute to the appearance of impropriety.

- 5) If selected as a participant you must execute all waivers and agreements required by Producers or any of their designees, licensees, affiliates, parents, subsidiaries, successors and/or assigns.
- 6) You will need to be available to the production for approximately four weeks or possibly longer in _____, 2008 (subject to change in Producers' sole discretion), and you must be willing to reside in a location to be designated by Producers.
- 7) If selected as a semi-finalist, you must be willing to submit medical information to the production and submit to a medical examination, psychological examination, and background checks if and to the extent required by Producers.

8) In exchange for Producers' consideration of you as a participant in the Program, you hereby give the following acknowledgements, consents and releases:

(a) By signing below, I hereby acknowledge that: (i) I have read and I meet and agree to be bound by the eligibility requirements set forth in this application; (ii) I have completed this application honestly and accurately; (iii) if any of the information in this application is found to be false or incomplete, this will be grounds for my dismissal from the contestant selection process, and/or from the contest and/or from the Program if selected; (iv) even if I meet the eligibility requirements, Producers have no obligation to interview me, and/or select me as a contestant; (v) my voice, actions, and likeness will be recorded as a part of this application and contestant selection process, and I understand that Producer may, but is in no way obligated to, actually use such recording within the Program or in any other manner; (vi) even if I am selected as a contestant, Producers have no obligation to conduct the contest or produce the Program, and Producers have no obligation to broadcast the contest or Program, even if conducted or produced; (vii) all decisions by Producers concerning selection of the contestants for the Program are final and not subject to challenge or appeal for any reason; and (viii) Producers have no obligation to return any materials submitted by me as part of the application process, whether or not I am selected as a contestant.

(b) Any material I provide to Producers (including, without limitation, videotapes, photographs, etc.) and all material that Producers creates as part of this application and contestant selection process shall remain the sole property of and shall be freely assignable by Producers. I further understand and agree that whether or not I am selected for any further consideration as a contestant on the Program, Producers shall nevertheless have the right to use my name, voice, likeness, appearance, biographical information, any information or material provided by me to Producers, and any motion or still pictures or recordings Producers may make of me, in any and all media now known or hereafter devised, worldwide in perpetuity, and I hereby release Producers from any and claims, actions, damages, liabilities, losses, costs and/or expenses arising out of or resulting from Producers' exercise of its rights hereunder.

(c) I hereby authorize Producers to investigate, access and collect information about me, about any of the statements made by me in this application, any supporting documents and any other document that I submit, have signed or do sign in connection with my application to be selected as a contestant or participant in the Program, or any other written or oral statements I make in connection therewith. I irrevocably authorize Producers to secure information about my experiences from my current and former employers, associates, friends, family members, educational institutions, government agencies, any branch of the military, credit reporting agencies, and any references I have provided, and I irrevocably authorize such parties to provide information concerning me. I hereby unconditionally and irrevocably release and forever discharge all such parties and persons from any and all claims, actions, damages and liabilities arising out of or in connection with any such investigation. I specifically authorize investigation of my employment records, medical records, and government records, including, but not limited to, my motor vehicle records, criminal records, civil records, military records and credit and/or consumer report(s). I acknowledge and agree that any such information obtained by Producer pursuant to this paragraph or otherwise may be used for purposes of selecting contestants in the Program, and may be described or otherwise related in and in connection with the Program.

(d) I hereby authorize Producers to conduct psychological and physical examinations and background investigations of me as required by Producers in Producers' sole discretion. I further authorize the individuals conducting such examinations and investigations of me to disclose to Producers and to each of their representatives all information about me obtained in connection with such examinations or investigations, and I hereby authorize Producers to utilize such information in selecting contestants for the Program.

(e) I expressly understand and agree that my rights and remedies against Producers shall be limited to the right, if any, to recover money damages in an action at law, and that I shall not be entitled to terminate or rescind any agreement between me and Producers or any of the rights I grant to Producers, or to enjoin or restrain the development, production, distribution, advertising or other exploitation of the Program or any rights therein.

(f) I will defend, indemnify and hold harmless Producers, and each of their respective officers, directors, agents, representatives and employees, from and against any and all claims, actions, damages, liabilities, losses, costs and expenses (including, without limitation, attorneys' fees) that in any way arise out of or result from my breach of any of the confidentiality or other provisions of this application.
