  - (b) Any television network, station or channel, cable network or satellite network that airs or that may air the Program;
  - (c) Any person or entity involved in the development, production or distribution or other exploitation of the Program or any variation thereof; including, without limitation, Flashlight 21, Inc.
  - (d) Any sponsor of the Program or its advertising agency; or
  - (f) Any person or entity supplying services or prizes to the Program.

In addition, Producers reserve the right to render ineligible any person whom any of them determine, in their sole discretion, is sufficiently connected with the production, administration, judging, or distribution of this Program such that his or her participation in the Program could create or contribute to the appearance of impropriety.
