## **OPERATION FABULOUS (working title)**

## **ELIGIBILITY REQUIREMENTS**

Please note, the following eligibility requirements and terms must be met in order to proceed with the application process for "OPERATION FABULOUS" (working title) (the "Series"). (Unless otherwise indicated, the eligibility requirements apply to both the makeover participant applicant and the style buddy applicant.)

- 1. To be a makeover participant, applicants must be female and 19 to 32 years of age at the time of application. A style buddy can be male or female and can be of any age.
- 2. If you are selected by the Producers you may be asked to be available in the month of October, 2008 as part of the final selection/interview process. You will be notified of the exact date you will be asked to be available, which date may be changed at any time by Producers in their sole discretion. Your schedule while filming will be entirely at the Producers' sole discretion. All dates and locations listed in these eligibility requirements and in the application form are subject to change in the Producers' sole discretion.
- 3. If selected as a participant, you must be available for 2-3 days in October, 2008.
- 4. If you are chosen to be a participant in the Series, you must make any necessary arrangements with your employer and family in anticipation of their absence from home.
- 5. You must be legal residents of and must live in the fifty (50) United States or the District of Columbia.
- 6. You must not now be a candidate for public office, and if selected, must agree not to become a candidate for public office until one year from the taping of all episodes of the program in which they appear.
- 7. You must be in excellent physical and mental health.
- 8. Potential makeover participants and style buddies must complete and return a Makeover Participant Application or Style Buddy Participant Application, as applicable. Applications must be written clearly or typed.
- 9. If selected as a participant, you must complete a Participant Agreement and Release, which will be furnished by the Producers and will include among other things, release forms and waivers.
- 10. By applying for participation in the show, you authorize the Producers to conduct civil, criminal, financial, driver-history and any other type of background checks deemed necessary by the Producers.
- 11. Employees, officers, directors and agents of Two Cities Productions, The CW Television Network, Kristina Productions Inc. and/or of any of their respective licensees, assigns, partners, parents, affiliated and subsidiary companies and the immediate family (spouse, mother, father, sister, brother, daughter or son, regardless of where they live) or members of their same households (whether related or not) of such employees, officers, directors and agents are not eligible to be participants in the Series or participate in the application process.
- 12. The Producers reserve the right to change any of the eligibility requirements and terms, including the terms of any prizes to be awarded at any time without notice.
  - DEADLINE: ALL COMPLETED SUBMISSIONS MUST BE RECEIVED BY MIDNIGHT PACIFIC STANDARD TIME, October 15<sup>th</sup>, 2008.
- 13. All materials you send us (including photos) will be retained by the Producers and become the property of the Producers and will not be returned to you whether or not you are selected as a makeover participant or style buddy participant. Any expenses you incur during the application process including postage, shipping and materials

preparation (videotape, photos, etc.) are your sole responsibility. The Producers will not reimburse you for these expenses. Only one application per person is allowed. All decisions of the Producers are final and absolute and not subject to inquiry or appeal.

14. Applications will only be considered if they are completed and signed. Complete the application as described here and in the Makeover Participant Application or Style Buddy Participant Application, as applicable, and send the entire completed application to the Producers at the address below.

Complete applications that are sent to Producers shall consist of the following:

- Completed Makeover Participant Application or Style Buddy Participant Application, as applicable.
- Photographs of the potential makeover participant and style buddy, each clearly labeled on the back with potential "makeover participant" or "style buddy", as applicable, and with the person's name. One must be a shot of their face and another must be a full-length photograph of their entire (clothed) body.
- Legible copies of the (1) driver's license and (2) social security card for both makeover participant and style buddy.
- 15. Producers will be accepting completed applications now through and including deadline listed above, it being understood that such dates may be changed at any time without notice in the Producers' sole discretion. Send your completed application to the following address.
